Librarian, English team and tutors in year 7 and 8 have worked on encouraging all students to read for 20 minutes per day There are 3 informal assessments per year which tells us where interventions need to be CC said all students from the school are welcome to use the Desford library KG joined the meeting at 18.50pm We have had a reading academy where a peer mentoring intervention was introduced and it is run using post 16 students. Intervention groups identified and this is ongoing this year Big push on accelerated reader which is very well received by students, there are lots of rewards given out and information is put in the newsletter to parents Bedrock Vocabulary tier 2 vocabulary delivered by tutors (year 7/8) and extra English classes (year 9/10). Students read and then answer questions via a quiz and they get points.
